Home Education Plan Proposal

The Bedford School Committee recognizes the right of parents to educate their children outside of a school setting as provided by General Laws Chapter 76, Section 1. The law requires, however, that a child being educated outside of school must also be instructed in a manner approved, in advance, by the Superintendent or designee or the School Committee. The Bedford Public Schools does not approve home education programs for anything less than a full time instructional program.

Instructions:

One must obtain approval from the Superintendent of Schools or his/her designee prior to removing their child(ren) from the public schools and beginning a home education program. Please complete this form, attach any additional information, and forward it to: Assistant Superintendent of Schools, 97 McMahan Road, Bedford, MA 01730. Submission of this proposal should be at least twenty days (20) prior to the planned start of a home education program.

A parent/administrator conference may be scheduled to discuss the plan if it is deemed necessary. Ordinarily, you will receive a reply to your proposal within twenty (20) days from receipt of your application.

F. Appeal Process:

If the parent/guardian is dissatisfied with the Superintendent's decision on this application, an appeal may be made in writing. Parents have the right to a hearing to explain their plan and answer any questions. They may be represented by counsel and shall be provided reasonable notice of the time and place of such a hearing.
